

Legal Notice

Sealed bids will be received by the Boards of Education of Glenbard Township High School District 87, Queen Bee District 16, Glen Ellyn District 41 and Community Consolidated District 89 Du Page County, Illinois (hereinafter referred to as the "School Districts") on, Monday, March 28, 2011 at 2:00 p.m. central standard time for the Transportation Services for Regular Education Students. An award, if made, will be to the responsible bidder that provides the lowest price in the aggregate for all four of the school districts combined. Once a successful bidder is identified, each Board intends to award a separate contract to that same contractor for the price bid for that individual school district. Thus, after award is made, the successful contractor may have a separate contract with each school district. There will be no joint and/or severable liability among the school districts for the actions of another school district. If one Board decides not to approve a contract with the successful bidder, the bidder shall maintain its bid price for each school district that decides to approve a contract.

All bids must be submitted no later than Monday, March 28, 2011 at 2:00 p.m. at which time they will be opened and read aloud at the Glenbard Township High School District 87 Facility Center, 671 Crescent Boulevard, Glen Ellyn, Illinois. Bidders interested in attending the bid opening should arrive prior to 2:00 p.m. on Monday, March 28, 2011 at the District 87 Facility Center at 671 Crescent Boulevard, Glen Ellyn, Illinois.

Bidder's shall provide a certified check or a bid bond equal to ten percent (10%) of the value of the bid for the first year from a surety company with at least an "A" rating in Best's Key Rating Guide.

The Bid is to be enclosed in a sealed opaque envelope clearly marked, "**Original Sealed Bid for Transportation Services For Regular Education for Glenbard Township High School District 87, Queen Bee School District 16, Glen Ellyn School District 41 and Community Consolidated School District 89**".

Each Board of a school district also reserves the right to reject the bid of a Bidder who has previously failed to meet the terms of this or similar contracts or fails to demonstrate the ability to meet the terms of the Contract.
