# GLENBARD'S MARCH 19 REFERENDUM WILL ADDRESS FACILITY NEEDS, POSITIVELY AFFECT STUDENT ACHIEVEMENT

GLENBARD DISTRICT 87
FACILITY IMPROVEMENTS
REFERENDUM

Glenbard District 87 students receive a high-quality education that prepares them for life after high school. However, students are learning in buildings that range in age from 51 to 101 years old and need significant improvements.

Now we are working on the next plan, which continues the investment in the warm, safe, dry needs of the previous plan, as well as educational spaces.

The new Facility Master Plan identified \$312 million of priorities for improvements at each of our four high schools. On March 19, 2024, Glenbard District 87 will ask voters to approve \$183 million of bonds to fund the plan, and the district will contribute \$129 million from its operating revenues over the next 10 years to fund the overall plan. The cost of the bond issue on the ballot is approximately \$4 per week for a taxpayer whose home has a market value of \$300,000.

# Our four high schools are ranked in the top 21% of Illinois schools

in U.S. News & World Report's 2023-24 listing of America's Best High Schools. Schools are evaluated based upon their performance on state assessments, graduation rate and how well they prepare students for college.

This year, we have 1,006 students participating in at least one dual credit

**course**, which results in students earning both college credit and high school credit.

Our District College Board Equity and Excellence AP score is 41%, which exceeds the state average of 26.9% and national average of 22.5%. This measures the percentage of students who graduate with a 3 or higher on an Advanced Placement exam.

All of our high schools have been awarded an **AP Honor Roll Designation and the AP Access** 

**Award** by the College Board. This signifies significant achievement in student access and success in AP, including students of underrepresented populations.

# Glenbard March 2024 Referendum Details

For generations, Glenbard District 87 students have benefitted from an outstanding high school experience. We want to continue this tradition. Our four high schools, which range in age from 51 to 101 years old, have numerous capital improvement needs. The March 19, 2024 referendum seeks to secure funding necessary to make crucial facility improvements.

# **Referendum Summary**

- Glenbard District 87 is asking voters to approve a \$183 million bond issue in the March 19, 2024 election to fund its new 10-year facility master plan.
- The bond proposal will cost the owner of a \$300,000 home about \$4/week.
- Over the next 10 years, the district will fund an additional \$129 million of improvements from its operating budget, for a total of \$312 million of facility projects.
- The proposed improvements are **addressing real needs.** While our buildings are structurally sound, they are between 51 and 101 years old. We must make sure our educational spaces support today's best practices in curriculum and instruction.
- The referendum **continues our history of responsible planning.** We spend less on our facilities and operations, carry less debt, & have a lower tax rate than the vast majority of districts in the metro area.
- Addressing these needs now allows us to continue to **protect what matters most** by avoiding expensive, future repairs. Doing so will make sure we continue to provide the educational experiences our children and families need and deserve.

## **Our Needs**

Our 10-year plan will address prioritized needs in the following areas:

## Safety and security

• Upgrades are needed to safety & security systems and entrances to keep up with today's best practices.

## Classroom and science lab improvements

- Upgrade out-of-date science labs.
- Add windows and replace lighting and flooring where needed.
- Align classroom design with current best practices in curriculum and instruction.

### Infrastructure

- Our 4 high schools vary in age between 51 and 101 years old. When crucial infrastructure ages and becomes inefficient, operating costs increase, taking money away from instructional priorities.
- Continue to upgrade and renovate, where needed, building infrastructure items like roofs, windows, electrical systems, plumbing, and heating and cooling systems.

## Overcrowding

• Upgrade cafeteria space to eliminate overcrowding and provide flexible learning and program spaces.

## Access to student support services

 Relocation of commons areas to increase accessibility for student support services such as social workers and counselors.


# What It Means to Student Learning

# **Key Takeaways**

- Improvements to facilities are **necessary** to support best instructional practices.
- Without a large one-time revenue source, some key needed facility improvements are not feasible. The enhancements to instructional spaces (e.g. classrooms, science labs, fine arts, athletics) cannot be completed without sufficient funding.
- Since construction costs are increasing, efficient borrowing now yields a high return on the investment in student opportunities long term.
- The District 87 board and administration demonstrated **responsible stewardship** with the 2014 referendum (\$154 million invested over 10 years with \$35 million from referendum).
- District 87 facilities particularly entrances, common spaces and high-traffic areas are not currently meeting the standards of large, comprehensive high schools.
- Comprehensive investment is needed for District 87 to be competitive within the region in offering a high-caliber high school education for all Glenbard students.
- Raising the standard of excellence in our facilities is an investment in our communities.

### **FUNDING NECESSARY TO ADDRESS FACILITY NEEDS**

Our four high schools range in age from 51 to 101 years old. While our buildings are structurally sound, they are old and many conditions are out-of-date. The March 19, 2024 referendum seeks to secure funding necessary to make crucial facility improvements.

Our 10-year facility plan will address prioritized needs in these areas:

### • SAFETY AND SECURITY IMPROVEMENTS

The safety and security of our students, faculty and staff must be the highest priority when addressing facility needs. If voters approve our referendum, safety and security features of all Glenbard high schools will be enhanced.

#### • LABS AND CLASSROOMS WILL BE UPDATED


Much has changed in the many years since our high schools were built. Classrooms and labs in all of our high schools are in need of updates to accommodate best practices in education.

### • PHYSICAL CONDITION OF OUR HIGH SCHOOLS WILL BE PROTECTED

In total, our four high schools represent a \$1 billion investment by our community. The "newest" building is more than 50 years old. Just like with a home, the buildings need repair, renovation and upgrades to remain in good working condition — things like roofs, windows, electrical and plumbing systems. Failure to address these needs today will result in higher future costs as conditions deteriorate.



The main entrance at Glenbard East is congested when more than 2,000 students arrive in the morning to safely check-in with their student ID.



Glenbard North's outdated science labs are not meeting our students' needs, as they don't align with best practice in curriculum and instruction.



The main entry to Glenbard West is congested. The secure vestibule is very small and while functional, should be larger to accommodate the student body.



Glenbard East's cafeteria is a large student space that is limited as one dimensional in its usage.



Glenbard South's science labs are outdated. They don't align with best practice in curriculum and instruction.



Glenbard South's main entrance can be congested with hundreds of students arriving and departing during the day. It also needs to be a place that allows for everyone to safely and efficiently check in when they arrive at the building.

# GLENBARD PROVIDES TAX RELIEF THROUGH \$2 MILLION DEBT SERVICE LEVY ABATEMENT

When the Board of Education approved the tax levy in November 2023, it included a \$2 million abatement (reduction) from the debt service (non-operating levy) to provide relief to our taxpayers. Without the \$2 million abatement this year, there would be a projected increase of an additional \$30 for the owner of a home with a market value of \$300,000.

This is the second consecutive year the board approved an abatement. Last year, the abatement was \$1.5 million.

The result of this year's reduction will be a shortfall in the Debt Service Fund that will be covered by prior year cash reserves. There is no impact on the operating budget and the financial profile score rating. This approach ensures that we are able to fully fund instructional programming while ensuring that we are fiscally responsible to our community.

We are committed to fiscal responsibility. We are pleased with the results of the fiscal year 2023 audit. Highlights of the audit are as follows:

- 1. We achieved all major financial objectives:
  - a. Balanced budget in our operating funds;
  - b. Strong cash position; specifically, no short-term borrowing was required to meet obligations;
  - c. Solvency position realized with 197.14 days cash on hand achieved. This slightly exceeds the target 180 days established by the Illinois State Board of Education (ISBE).
- 2. Our Annual Financial Report indicates we achieved financial recognition status from the ISBE for the 17th year in a row. Financial recognition is ISBE's highest category of financial strength.

## **GLENBARD BOARD OF EDUCATION MEETINGS**

Typically, the Board of Education meets twice a month on a Monday evening. Meetings are open to the public. During the school year, meetings rotate among the four Glenbard high schools and the administrative center. Also, a board meeting is

held in October at the Technology Center of DuPage in Addison and in January at the Linda Jackson Center for Senior Citizens in Glendale Heights. Board meeting dates, locations and agendas are available at glenbard87.org under the School Board tab.

# NEW SCHEDULES PROVIDE SUPPORT, EXTENDED LEARNING OPPORTUNITIES

We introduced the Glenbard Hour in our school day schedule this year. This designated time during the school day benefits our students, whether they need help with classwork or are doing well and want to tap into extended learning opportunities

During the twice weekly Glenbard Hour, students are seeking help; learning new concepts; and gaining new skills. This dedicated time each week allows students to access their teachers for academic support. It also reduces the need for students to arrive early or stay after school to seek assistance.

Most Glenbard Hour sessions are devoted to student agency. Students use this time in areas that most benefit them. Examples include:

- Students getting help from their teachers
- Extending students' learning
- Students collaborating with peers
- Test and lab retakes
- Future planning through college/postsecondary presentations

The Glenbard Hour also features advisory sessions on topics such as:

- Course selection
- Postsecondary planning
- Skill development in self-management, self-awareness, responsible decision making, relationship building and social awareness
- Safety drills
- Surveys
- Career exploration
- Assemblies
- Award ceremonies and more.

### 2024-25 SCHOOL YEAR SCHEDULE

We are excited to launch a hybrid block schedule in 2024-25 and implement later start and dismissal times. This schedule will provide deeper learning experiences for our students and enhance our Profile of a Graduate competencies. The schedule for the 2024-25 school year includes eight periods per day on Mondays, Tuesdays and Fridays with Glenbard Hour on Mondays and Fridays; and a block schedule with four 90-minute periods on Wednesdays and Thursdays.

- Eight periods per day on Mondays, Tuesdays and Fridays with Glenbard Hour on Mondays and Fridays; and a block schedule with four 90-minute periods on Wednesdays and Thursdays
- A later start time and dismissal time, anticipated to be 8 a.m. to 3 p.m. Research indicates a later start time has physiological benefits for adolescents that lead to better engagement and increased student learning.
  - o Note: the length of the school day does not change.
- Increased opportunities for deeper learning during the 90-minute blocks.

Throughout this school year, our talented educators are participating in our professional development sessions that prepare them for the hybrid block schedule. They are learning about topics such as: student-led discussion and activities; student supports within the class; student choice; planning for the week to maximize deep learning on block schedule days and teaching about our Profile of a Graduate.
